Section II: Object of the design contest /description of the project

II.1) Description

II.1.1) Title attributed to the design contest /project by the contracting authority/entity

Concept of an architectural design of a building of the Embassy of the Republic of Poland in Berlin

II.1.2) Short description

The purpose of the contest is to obtain the best possible functional, architectural and operational architectural concept for an integrated building or a building complex of the Embassy of the Republic of Poland in Berlin, together with a concept for the zoning plan.

The design concept should fully display the new building, in both aesthetic and functional terms – i.e. it should depict a dialogue between the new building and the existing surroundings, its immersion in the urban fabric, including in particular the relation between the main facade and the street frontage, the interaction between interior and exterior spaces, how users' impressions are directed to different zones within the building, the consistency in retaining the independent character of the individual functional blocs dedicated to the Embassy and the Consular Section. Moreover, the architectural concept should account for novel architectural ideas that will give the building a unique and original quality, emphasizing its exceptional and prestigious nature.

The object of the contest is a visual and written design containing a zoning plan concept and architectural and construction solutions for a building or a building complex of the Embassy of the Republic of Poland in Berlin together with the Consular Section located at 70/72 Unter den Linden Street.

The design concept for the premises (a building or a building complex) should fulfil all of the requirements specified in the assumptions and guidelines for the functional-utility programme and offer design solutions that guarantee optimum cost effectiveness of both the construction and the maintenance of the new premises, while at the same time maintaining a pre-assumed high standard. Consequently, the use of state-of-the-art, environmentally-friendly and energy-efficient technologies is recommended.

The design should cover the premises of the Embassy of the Republic of Poland in Berlin.

Contest Participants should take into account the character and prestige of the location, as well as the limitations and requirements resulting from:

- the Ordinance on the External Shape of Building Constructions in Unter den Linden street, on Museum Island (Museuminsel) and in Gendermenmarkt square (The Ordinance on the Historical Centre Zoning Plan) of 21 August 2009 (GVBI [Gazette of Laws and Ordinances], p. 692),
- the assumptions and guidelines for the functional-utility programme,
- the zoning plan for the Dorotheenstrasse, Schadowstrasse, Unter den Linden and Wilhelmstrasse block of streets.

A detailed description of the object of the design contest is provided in the Rules, made available according to the provisions of section VI.2).

III.1) Criteria for the selection of participants:

The Participants of the contest may be natural persons, legal persons, and organizational

- units without legal personality that submit contest applications and meet the conditions set out in Article 22.1 of the Act, referring to:
- a) possession of the necessary permits to carry out the specified activity or activities, if the obligation to possess such permits is required by law;
- b) possession of knowledge and experience;
- c) possession of the relevant technical potential and persons capable of performing the contract;
- d) economic and financial standing.
- 2. To confirm that they have fulfilled the condition specified in section III.1) 1. b), Participants must demonstrate that they possess the relevant experience. Participants who have submitted their contest applications must demonstrate that in the course of the last 3 years before the expiry of the time-limit for submitting contest applications or, if the period of their business operation is shorter, then during such period, they have duly performed services demonstrating that they have fulfilled the condition of knowledge and experience, i.e. they have duly performed services involving:
- a) the creation of building permit designs on the basis of which buildings have been or are being constructed with each building having a total usable area of 5 000 m² (square metres) or more, located in an intensely urbanized area; or
- b) the creation of multi-sector tender design projects or detailed designs on the basis of which buildings have been or are being constructed with each building having a total usable area of 5 000 m² (square metres) or more, located in an intensely urbanized area, and each equipped with an alarm system, a data processing centre (server room), an air conditioning system, a ventilation system, BMS and a structural network.

Requirements shall be deemed fulfilled if the Participant has:

- created at least two building permit designs (BPD) referred to in section III.1) 2. a).; or
- created at least two multi-sector tender design projects (MTDP) referred to in section III.1)2. b) or created as least two multi-sector detailed designs (MDD) referred to in section III.1)2. b); or,
- created at least one building permit design (BPD) referred to in section III.1)2. a) and at least one multi-sector tender design project (MTDP) referred to in section III.1)2. b); or,
- created at least one building permit design (BPD) referred to in section III.1)2. a), and at least one multi-sector detailed design (DD) referred to in section III.1)2. b).

Instruction concerning combinations that fulfil the above-mentioned conditions: 2x MTDP or 2xMDD or 2xBDP or 1xBDP+1x MTDD or 1xBDP+1x MDD.

- 3. To confirm their fulfilment of the condition referred to in section III.1)2. c), the Participants must demonstrate that they possess or will possess a team of at least four persons comprising:
- a) at least one person possessing a unlimited construction license in architectural design (the person is required to provide documentation of having created in the 5 years before the expiry of the time limit for submitting contest applications at least two building permit designs or two tender design projects or two detailed designs which served as a basis for completed or on-going construction of the relevant public buildings, with a total usable area of no less than 5 000 m² (square metres) each, located in an intensively urbanized area;
- b) at least one person possessing an unlimited construction license in construction design;
- c) at least one person possessing an unlimited construction license in designing electrical and power networks, installations and equipment;
- d) at least one person possessing an unlimited construction license in heating, ventilation, gas, waterworks and sewage networks, installations and equipment;
- e) at least one person possessing an unlimited construction license in telecommunications.

The roles of the team members as described in section III.1)3. a) through e) can be filled by the same persons, provided that each team member referred to in section III.1)3. a) through e) possesses at least one qualification referred to in section III.1)3. a) through e).

Team members referred to in section III.1) 3. a) through e) should possess unlimited construction licenses in their respective design specialisations, pursuant to the national laws of the country in which the person has received the relevant licence, and should be members of the relevant professional association and/or any other relevant organization, if the national laws of the country in which the person has received the relevant license require membership of a professional associations and/or any other relevant organization to practice a regulated profession.

- 4. Evaluation of the fulfilment of criteria required from the Participants shall be made according to a "fulfils/does not fulfil" formula. Failure to fulfil even one criterion excludes a Participant from the contest procedures.
- 5. Contest Participants who fulfil the requirements specified in the Rules shall be invited to submit a design contest entry.
- 6. As confirmation of the fulfilment of the contest participation conditions laid down in section III.1)1.,Participants are required to present:
- a) a statement of compliance with the participation conditions specified in Article 22.1 of the Act, in accordance with the template that has been annexed to the Rules;
- b) a list of services carried out in the past or at present to the extent necessary to demonstrate the fulfilment of the condition of knowledge and experience (pursuant to section III.1)1. b) in the course of 3 years before the expiry of the time limit for submitting contest applications, or, if the period of business activity is shorter, then during such period. The list should include the scope, object, dates of execution, and contractors (name, address, telephone number, contact person), together with documents evidencing that such services have been or are being duly performed:
- c) a list of persons who will participate in the performance of the contract, along with information about their professional qualifications and experience necessary to perform the contract (pursuant to III.1)1. c), and about the scope of activities performed by such persons and information about the grounds on which Participant has such persons at his disposal;
- d) a written commitment from other entities to provide persons capable of performing the contract (if the Participant has listed persons at his disposal in the list referred to in section III.1) 6. c);

- b) programming and spatial planning value, including correct functional solutions in the context of compliance with the assumptions and guidelines to the functional-utility programme and terrain conditions; correct immersion of the design in the structure and character of the area; quality and coherence of the concept design as a whole;
- architectural and urban planning value, including aesthetic value, visual attractiveness and adaptation of design solutions to the character and prestige of the area; creating a positive image of the state by user-friendly and attractive spaces, internal courtyard development plan in line with the urban design of the area;
- d) functional value, including the quality of functional and spatial solutions, ease of the building's use, conservation and maintenance, ensuring building and user security, autonomous functioning of the individual functional blocks dedicated to Embassy and Consulate activity, accessibility solutions for people with disabilities;
- e) economic viability, including the estimated investment costs, cost-effective maintenance, optimal energy-saving solutions, cost-effective construction and building materials, ability to adapt the office space to changing needs (differing numbers of users of a given space).
 All of the above criteria are of equal value and together amount to 100 percent of the final score.
