#### PREAMBLE

European society has arrived to the point where improvement of life conditions through consumption of goods and satisfaction of basic needs is not possible any more. At the turn of the new era, we want to discuss expectations of the public, architects, politicians, NGO's and all involved parties taking into account experiences with implementation of Architectural Policies in European countries. We want to help all countries, where architectural policies have not yet been approved by showing their importance and focusing attention on them.
